

SPECIFIC CALL FOR PAPERS TO THE WORKSHOP:

« EXPLORING THE FUTURE OF THE GLOBALIZATION IN THE AFTERMATH OF THE 2008 FINANCIAL CRISIS »

1. GENERAL ORGANIZATION

As detailed by the general presentation of the Conference (check on our website Recherche & Régulation), the organizers want to support collective research, on new or critical economic challenges, which in turn question the researchers' practices and methods. With this prospect in mind, the scientific committee has selected this workshop topic—and around thirty other ones.

This specific call will help you to submit a paper to the organizers of this specific workshop (otherwise you should check on our website to submit to another workshop or as a varia).

Paper proposals will be examined by the organizers of the workshop and by the scientific committee according to the schedule and requirements below:

SCHEDULE AND FORMAL REQUIREMENTS.

FORMATS. The topics addressed by contributions to the Research and Regulation 2015 Conference are not limited, but submitted papers must clearly set out how they are positioned: within epistemological or theoretical issues; conceptual or empirical; whether they present results, a survey or a programmatic approach.

The committee will also examine proposals that sum up state-of-the-art knowledge in specific areas, whether methodological or field-based. ¹

In addition, selected presentations will be proposed for publication in a variety of formats, such as peer-reviewed journals, books or proceedings; specifics will be provided by the organizers prior to the Conference.

3. SCIENTIFIC ORIENTATION OF THE WORKSHOP

The future of globalization has been fiercely debated over the past two decades. Being a multidimensional process through which interconnectedness increases between domains in a large number of countries around the world, questioning the future of globalization goes well beyond the issue of its intensification. In the last two decades the process of globalization has been marked by the constant expansion of trade (relative to GDP growth) and the continuous integration of the finance sector. The process driven by a free market ideology has been so steady and naturally spreading to all parts of the world that some could speak of a silent revolution. The 2008 financial crisis and what followed are likely to have changed the scene. Financial integration has been criticized and reforms of financial systems undertaken. A widespread economic

slowdown in developed economies has then slowed the growth of trade. Increases in barriers to trade have been reported. Restrictions on Foreign direct investments (FDI) have been rising. Efforts to meet environmental challenges are also bound to put new constrains on trade flows and investments. Meanwhile development of information and communication technologies are likely to contribute to changes in the forms and business models of international transactions.

The face of globalization is therefore changing. Question is to what extent can a globalization mainly based so far on market competition give way to more solidarity and more non market ties, be it more cooperation between states or between civil society organizations. Will such change be organized at regional levels or at a global one? To what extent will it be channeled by restrictions on trade and investments What becomes of financial integration strongly conditions this future. Growing environmental threat is also bound to have a major impact on international relations, be it in increasing solidarity or reducing exchanges. Growing distress and discontent, fueled by a general rise in inner country inequalities, may also push some countries towards more protectionism. The geography of globalization is also likely to change regarding the roles of megacities in international networking or the development of more specifically regional cooperation.

To explore these crucial features of the future of globalization, the panel will share different perspectives taken by political scientists and economists, all referring in various ways to the complementary traditions of the IPE (International Political Economy) and of the Regulation School.

TO SUBMIT A PAPER

1. PAPER PROPOSAL

To be considered, a paper proposal should be presented in a word-processing document that respects the following requirements:

First page: Paper title, professional status and contacts of author (if co-authors, use **boldface** for the correspondant)

Second page: Abstract in French and English (maximum 10 lines each, with 5 key words)

Third and fourth page:

— A summary presenting a detailed outline that addresses the following questions: What is the starting point? What is the key idea or argument? What is going to be demonstrated? Which scientific questioning and heuristic framework (and the theoretical or conceptual elements on which they are based)? What methodology is used? (when appropriate: what is the state of the art of which scientific issue?)

— A bibliography indicating the key references that will guide the author (10 maximum)

Proposals will be evaluated by the scientific committee according to the "double blind" procedure.

2. FULL PAPER

The definitive text must be received according to the calendar above in a digital word-processing file (Arial 10pt, single line spacing; margins 2.5 cm).

First page: Paper title, professional status and contacts of author (if co-authors, use **boldface** for the correspondant).

Second page: Abstract in French and English (maximum 10 lines each, with 5 key words) **Text: maximum 8,000 words**.

Note that each paper will be evaluated for possible publication after the colloquium, in a peer-reviewed journal or edited volume.
